## **Please note - AMPS By-Laws Article 7, section 3 states:**

A member shall be in arrears and shall not be considered active if his/her dues have not been paid as provided in Article 7, Section 1. **A \$10 surcharge will be assessed for dues paid during the month of January** and as provided in Article 7, Section 1. Any member who allows their membership to lapse beyond the last day of January of any year will have their membership revoked. These members can be reinstated into AMPS by reapplying for membership as per Article 8, paragraph 2 and will not be given preference over any other applicant should a membership waiting

list be in existence. **Reinstatement requires full payment of yearly dues applicable to their level of membership plus a \$25 reinstatement fee. Prorated fees do not apply to membership reinstatement.**
